Guideline

on the order of filling out the forecast-information on the demand for foreign labor force for the upcoming year, in accordance with the requirements of the "Procedure for Determining the Labor Migration Quota" approved by the Decision No. 124 of the Cabinet of Ministers of the Republic of Azerbaijan dated March 14, 2016, by indicating professions according to the Occupational Classification and submitting it to the State Migration Service of the Republic of Azerbaijan

The forecast-information form for the demand of foreign labor force for the upcoming year is to be completed in the following order, by indicating professions according to the Occupational Classification.

I. Using the Electronic Service:

1. Visit the official website of the State Migration Service of the Republic of Azerbaijan (<u>www.migration.gov.az</u>), select the "**Electronic Services**" section, and then enter the "**Forecast Information on the Demand for Foreign Labor**" electronic service.
